

# South Carolina Ground Water Association Scholarship

## ***GUIDELINES***

- Scholarship applications are made available in October for the following academic year and must be submitted by February 1.
- One scholarship will be given in the amount of \$1000.
- Applicants must be members or the children, grandchildren or spouse of a member in good standing of SCGWA for not less than three years.
- Scholarships are available to undergraduates only.
- Applicants must have maintained at least a 2.5 grade point average during their last two years of formal education. Applicants who have been out of school for more than two years may submit transcripts or no less than two employment related recommendations.
- Applicants do not need to be pursuing industry-related degrees; however, applicants who are pursuing degrees in water well or ground water related studies will be given special consideration.
- Applicants may be selected to receive funds only twice.
- The SCGWA executive director will verify membership of applicant sponsors before award recipients are selected.
- Scholarship recipients will be notified by early May, in time for them to be acknowledged at their high school award ceremony.
- Press releases will be sent to local newspapers upon applicant's request.
- Winner will be acknowledged by the Awards Committee chairperson at the Spring Meeting.

## ***APPLICATION PROCESS***

Each year, the South Carolina Ground Water Association awards one scholarship in the amount of \$1000. Individuals can be awarded the scholarship twice in an undergraduate career. To file a completed application, it is necessary to follow the steps below, complete the enclosed forms as directed, and attach the required items.

**ELIGIBILITY:** Any properly executed application will be accepted. However, a high priority will be given to any applicant who is pursuing a degree in water well or ground water related studies. To qualify, the applicant must:

- Be an SCGWA member or the child, grandchild or spouse of an SCGWA member in good standing for not less than three years.
- Be a high school senior, high school graduate, or college undergraduate student.
- Maintain at least a 2.5 grade point average during their last two years of formal education. An applicant who has been out of school for more than two years may submit transcripts or no less than two employment related recommendations.

- Be able to provide transcripts including cumulative grade point averages (high school seniors) or the latest available transcript from an educational institution.

**PROCEDURE:** The applicant must complete the attached application in full and have submitted it to the proper location **BEFORE** the deadline. The deadline for applications is February 1. Applications must be postmarked by the deadline to be eligible.

**REVIEW:** Eligible applications are reviewed by the Awards Committee. Special consideration is given to individuals studying an industry related field. Evaluations are based on:

- Academic achievement, grade point average, honors received;
- Quality of the essay;
- Community involvement.

**DISBURSEMENT OF FUNDS:** The winning applicant will be notified by May 1. Scholarship funds will be disbursed to the school the applicant is to attend and mailed directly to the financial aid department of that school.
