## **WORKSHOP #1 (8:30-9:30am)**

### **Pump Sizing Theory**

**Robb Armstrong, CSP - Franklin Electric**

Robb Armstrong is a certified sales professional of water systems. He has 16 years with Franklin Electric and 11 years in the field working on solving issues. He has served 2 years as a board member for the NC Ground Water Association and recently co-chaired SC Ground Water Association's first ever golf tournament where \$6000 was raised. In this workshop, Robb will discuss basic pump design and operation. He will cover pump parts, pump operations, and pump sizing.

### **Hydrogeology of the South Carolina Piedmont**

Lee has 26 years of experience as a hydrogeologist with the SC Department of Natural Resources. After taking early retirement from DNR in 2011, he founded Hydrofinders and also became a Physical Sciences Instructor at North Greenville University. In this workshop, Lee will share information about the hydrogeology of the South Carolina Piedmont that he

has gathered over his many years in the field. If time permits, he will also discuss "Springs of South Carolina."
